Corrigendum to RFP

Reference Request for Proposal(RFP) for outsourcing of Visa services in Embassy of India Beijing,Consulate of India Shanghai and Consulate of India Guangzhou published on 18th May 2024.

The following modifications in the RFP may kindly be noted:

1. Service provider's services will be required just for the Visa and related queries and **NOT** for Consular, Passport and other services.

2. Everywhere in the RFP, Consular/Passport/Visa/OCI/PCC/Surrender Certificate (Renunciation of Indian Citizenship)/Global Entry Program (GEP) Verification/Miscellaneous Attestation stands replaced with only **Visa**.

3. Everywhere in the RFP, ICAC stands replaced with IVAC(Indian Visa Application Centre).

4. Due to CoVID-19 pandemic the number of 2021 and 2022 Visa applications were significantly lower and do not present the actual volume. Therefore, Visa numbers of 2023 (as per Annexure L) Mission/Post wise.

5. Chapter VII-1.point P, Annex E-PART II- IVAC shall remain open 5 days a week from Monday to Friday. Working hours of the Visa Application Centre will be 8:30 AM to 5:30 PM (excluding public holidays as per agreement with the Embassy and/or the Consulate) and timings for accepting the Visa applications will be 8:30 AM to 3:30 PM (excluding public holidays as per agreement with the Embassy and/or the Consulate) and timings for accepting the Visa applications will be 8:30 AM to 3:30 PM (excluding public holidays as per agreement with the Embassy and/or the Consulate). Minimum hours per week for acceptance of application and Back office working time stands revised as per the new timelines mentioned above.

6. Chapter V-1.point xii- EMD has been revised to RMB 42,553.

7. Chapter VII-A-point xi-Minimum number of submission counters in each location has been revised to 5 and Minimum Area Assigned in sq ft has been revised to 2000.

8. Chapter VII-B-point v,vii,viii and other points where postal application is mentioned- No Postal application will be accepted therefore all provisions related to Postal application stand deleted.
